What will you do?

Medical and Health Services Managers, also called healthcare executives, healthcare administrators and health planners. They plan, direct, and coordinate the medical and health services in an entire facility, physician office or department that conforms to changes in healthcare laws, regulations, and technology.

Where will you work?

Medical and Health Service Managers work in hospitals, clinics, and managed care facilities. They have a broad range of responsibilities which may include managing fiscal, facilities maintenance, personnel, and delivery of services to customers or patients. The scope and range of their responsibilities is determined by the size and type of organization they are managing.

What Experience do you need?

Prospective managers typically have some work experience in an administrative or a clinical role in a hospital or other healthcare facility. For example, nursing home administrators usually have years of experience working as a registered nurse. Other examples may have started their careers as a medical records and health information technician, administrative assistant, or a financial clerk in a healthcare office. Experience is considered along with education by employers. Additional certifications after a degree are also considered.

What type of Training do I need?

Medical and Health Service Managers does not require any state licensure, registration, or certification, unless you are a practicing RN, physician or nurse administrator.

Medical and Health Service Managers is an Advanced Skill level occupation requiring a minimum of a Bachelor's Degree in health administration, health management, nursing, public health administration, or business administration. Degrees that focus on both management and healthcare combine business-related courses with courses in medical terminology, hospital organization, and health information systems. For example, a degree in health administration or health information management often includes courses in health services management, accounting and budgeting, human resources administration, strategic planning, law and ethics, health economics, and health information systems. Employers may also prefer individuals with a Master's Degree.

Health Planners is an occupation title commonly found under the Medical and Health Service Managers umbrella. They have similar duties, but are primarily focused on research to implement procedures either as clinical healthcare diagnoses and treatments and services to individuals, or population basedhealthcare such as wellness and disease prevention. They mainly work for large non-profit or for-profit organizations in hospitals, local or state government agencies, and large nursing home businesses.
