Texas Live! will bring over 1,000 new permanent jobs to the City of Arlington and Tarrant County

Hiring Fair will take place on April 26th at Globe Life Park in Arlington

Arlington, TX (April 3, 2018) – The Texas Rangers, The Cordish Companies and Workforce Solutions for Tarrant County are excited to come together to begin hiring initiatives for Texas Live!, one of the largest and most exciting sports-anchored developments currently under construction in the Arlington Entertainment District. Scheduled to open late summer/early fall of this year, Texas Live! will house 200,000 square feet of best-in-class dining and entertainment space and a 5,000-capacity outdoor event pavilion. The project is bringing over 3,000 new jobs to the City of Arlington and Tarrant County, including 2,000 construction jobs and 1,025 permanent jobs. The hotel will add an additional 220 permanent jobs to the region upon opening.
